MYSA boys and girls teams have won many Kenyan and international youth championships. Mathare United FC has won several cup championships and is one of the top teams in the Kenyan Premier League. The Mathare youth also won the UNEP Global 500 Award for environmental innovation and achievement (Rio de Janeiro, 1992); first CAF/African Youth Development Award (Johannesburg, 2001); Prince Claus Award for cultural achievement (Amsterdam, 2003); World Sports Academy/Laureus Sport for Good Award (Lisbon, 2004); International Fair Play Prize (Athens, 2004); Score4Africa environment award (London, 2008); Common Ground Award for community and peace building (Washington, 2010) and Beyond Sports Judges Award for Leadership in Sport (Cape Town, 2011). The MYSA youth were the FIFA Football for Hope champions during the FIFA World Cup in Germany in 2006 and in South Africa in 2010.
